- 2. THE SALE WILL BE HELD ON THE 3RD FLOOR IN ROOM 303 OF THE PULASKI CO COURTHOUSE, 100 MAIN STREET, SOMERSET KY, 42501.
- 3. CHECK IN TIME FOR THE SALE WILL BE BETWEEN 8:15AM AND 8:55AM THURSDAY AUGUST 17, 2023 EASTERN STANDARD TIME.
- 4. EACH PURCHASER WILL BE GIVEN A LIST OF AVAILABLE TAX BILLS.
